The **Metropolitan Borough of Solihull** (in this Order called “the Council”) hereby make the following Order:

The land described in the Schedule below and which is in the area of the Council is hereby designated for the purposes of Section 13(2) of the Criminal Justice and Police Act 2001.

This Order may be cited as the Metropolitan Borough of Solihull (Alcohol Consumption in Designated Public Place) (Balsall Common) Order 2002 and shall come into force on the 1st day of October 2002.

All the areas shown hatched black on the map attached to this Order to which the public have access being within the area bounded by Balsall Street from Needlers End Lane to Balsall Street East to Alder Lane to Kelsey Lane to Meeting House Lane to Station Road to the railway line to Lavender Hall Lane to Park Lane to Kenilworth Road to Dengate Drive to Greenfield Avenue to Needlers End Lane to Balsall Street including the park, public car parks and the following roads:
