The **Metropolitan Borough of Solihull** (in this Order called “the Council”) hereby make the following Order:

The land described in the Schedule below which is in the area of the Council is hereby designated for the purposes of Section 13(2) of the Criminal Justice and Police Act 2001.

This Order may be cited as the Metropolitan Borough of Solihull (Alcohol Consumption in Designated Public Place) (Knowle, Dorridge and Bentley Heath) Order 2002 and shall come into force on the 1st day of October 2002.

**SCHEDULE**

**KNOWLE, DORRIDGE AND BENTLEY HEATH**

All the areas shown hatched black on the map attached to this Order to which the public have access within the area bounded by Windmill Lane to Mill Pool Lane to Darley Green Road to Norton Green Lane to Warwick Road to Wilsons Road to Kixley Lane to the Grand Union Canal to Hampton Road to Warwick Road to Lodge Road to Longdon Road to Tilehouse Green Lane to Browns Lane to Widney Road to Four Ashes Road to Box Trees Road to Earlswood Road to Grange Road to Windmill Lane.

Including: Hanbury Road Recreation Ground, Dorridge Park, Four Ashes public open space together with other incidental public open space, public car parks, and shopping areas together with the following roads:
