The Metropolitan Borough of Solihull (Hampton in Arden – Local Area) (Total Prohibition of Waiting) Order 2011

NOTICE IS HEREBY GIVEN THAT the Council proposes to make this Order under the Road Traffic Regulation Act 1984 as amended and under all other enabling powers. The Order, if implemented, will introduce the following:-

Total Prohibition of Waiting

B4102 High Street – on its north western side from Meriden Road and Old Station Road in a generally south westerly direction for approx' 187m, to a point approx' 14m south west of Shadowbrook Lane; and on its south eastern side from Meriden Road and Old Station Road for approx' 158m, to a point approx' 5m south west of Fentham Road.

B4102 Meriden Road – on its north western side from High Street and Old Station Road in a generally north easterly direction for approx' 21m; and on its south eastern side from High Street and Old Station Road in a generally north easterly direction for approx' 19m.

Old Station Road – on its north eastern side from High Street and Meriden Road in a generally north westerly direction to a point approx' 15m north west of the entrance to the Old Station Club House. On its north western side (i) from High Street and Meriden Road in a generally north westerly direction for approx' 28m; (ii) from a point approx' 125m north west of High Street and Meriden Road for approx' 32m, to a point approx' 16m north west of Fiddlers Green; and (iii) from a point approx' 224m north west of High Street and Meriden Road (in the vicinity of No. 16 Old Station Road) for approx' 123m, to a point 347m north west of High Street and Meriden Road (in the vicinity of Old Station Bungalow); and (iv) from a point approx' 398m north west of High Street and Meriden Road for approx' 41m, to a point approx' 15m north west of the entrance to the Old Station Club House (in the vicinity of No 29 Old Station Road).

Fentham Road – on its northern side from B4102 High Street in a generally easterly direction for approx' 48m. On its southern side from B4102 High Street in a generally easterly then southerly direction for approx' 41m.

Fiddlers Green – on both sides from Old Station Road in a generally easterly direction for approx' 13m.

Shadowbrook Lane – on both sides from B4102 High Street in a generally northerly direction for approx' 55m, to a point approx' 11m north of Fentham Green.

The spur of Shadowbrook Lane located north of the War Memorial - on both sides for its entire length.
