4. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at PO Box 18, Council House, Solihull, West Midlands, B91 9QS by **5 pm on Thursday, 14th April 2011**.
5. Applications to vote by proxy at this election must reach the Electoral Registration Officer at PO Box 18, Council House, Solihull, West Midlands, B91 9QS by **5 pm on Thursday, 21st April 2011**.
6. Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurred after 5 pm on Thursday, 21st April 2011, must reach the Electoral Registration Officer at PO Box 18, Council House, Solihull, West Midlands, B91 9QS by **5 pm on Thursday, 5th May 2011**.
