### LEVEL 2 TRAINING:

### Working Together to Safeguard Children And Young People (2 Days)

This course will be presented by members of the LSCB pool of trainers

#### Aims

This course is designed to meet DCSF requirements for training at Level 2, and succeeds the now discontinued Core Training programme.

The course will promote effective multi-agency safeguarding practices, in partnership with children, young people and families, from the point of first concerns about a child to the time when an Initial Child Protection Conference is held and a Core group is established. This course will give particular attention to:

- ☺ Child-centred practice
- ☺ Clarity about the roles and functions of self and others
- ☺ Practising in accordance with Solihull LSCB's Safeguarding Procedures
- ☺ Collective responsibility

#### Objectives

By the end of the course, participants will:

- ☺ Have explored the processes of identifying harm, assessing, planning and intervening, including the exploration of issues of diversity and discrimination
- ☺ Be clear about their own role in safeguarding children and young people, and that of others
- ☺ Understand the nature of effective collaboration, communication, information sharing and recording
- ☺ Appreciate the impact of their own interviewing style, decisions and actions on other professionals, volunteers and family members
- ☺ Be able to work together with others in accordance with 'What to do if...' Guidance and with Solihull LSCB Safeguarding Procedures
- ☺ Know when to involve others, and when to access guidance and support
- ☺ Have considered the potential effects of personal, cultural and religious beliefs on safeguarding practice
- ☺ Understand the contributions they can make to assessment, planning, intervention and review processes

## SECTION 2 - LSCB TRAINING PROGRAMME 2010 - 2011

### LEVEL 2 TRAINING: Level 2 'Refresher and Update' Training

This half-day course will be presented by the LSCB Training and Development Officer, in partnership with colleagues from the LSCB Level 2 pool of trainers.

#### Aims

This course offers an opportunity for all those who have attended the Level 2 course to update and refresh their knowledge and understanding of effective single and multi-agency safeguarding practices.

Practitioners and managers should attend this training course two years following their attendance on the Level 2 course, and then every following two years.

The content of the course will evolve continuously to take account of any important national and local developments, including learning about what we do well, and from national and local serious cases.

#### Objectives

By the end of the course, participants will have:-

- ☺ Re-visited key learning points from the Level 1 and 2 training courses, and updated their knowledge about:-
  - ☺ The identification of harm to children
  - ☺ Appropriate responses to safeguarding concerns
  - ☺ The law and the Solihull LSCB Safeguarding Procedures
  - ☺ Key elements of effective multi-agency safeguarding practice
  - ☺ Related issues of diversity and discrimination
- ☺ Had opportunities to explore issues and questions arising from their own practice
- ☺ Had opportunities to consider new local and national developments relating to best safeguarding practices
- ☺ Had opportunities to consider any changes they need to make to their own practices
- ☺ Had opportunities to raise any issues that need taking further through LSCB channels
