Anyone wishing to address the Inspector must make this known to the Programme Officer by Tuesday 5<sup>th</sup> October 2021 either by email or telephone after reading the Inquiry Attendance Information set out below.

Physical attendance will only be permitted if capacity allows. People with physical or sensory disabilities who have an interest in the appeal and would like to attend the Inquiry may wish to contact the officer at the head of this letter to discuss any special provisions that may need to be in place.
