**Evidence of income**

To be eligible for 2 year old funding under Section B, your families’ annual household income must be no higher than £15,400 a year or less after tax.

This includes any wider income or support you may be receiving in addition to any earnings from employment. Please also provide a document to show this – this could be a bank statement, a pay slip or an employment contract.
