This statement sets out Solihull Council's flexible eligibility criteria for the Energy Company Obligation (ECO4) scheme from April 2022 – March 2026.

The ECO4 scheme will focus on supporting low income and vulnerable households. It aims to improve the least energy efficient homes, helping to meet the Government's fuel poverty and net zero commitments.

The flexible approach for Local Authorities (LAs) to identifying fuel poor and vulnerable households who may benefit from heating and energy saving measures is referred to as "ECO4 Flex".

The Council welcomes the introduction of the ECO4 Flex eligibility routes as it helps the Council achieve its plans to improve the homes of those in fuel poverty or vulnerable to the cold.

The Council is publishing this Statement of Intent (SOI), on the 13 December 2022 to confirm that each of the households declared will adhere to at least one of the four available routes outlined in the table below:

Four routes for Flexible Eligibility Criteria

Route 1:	EPC bands D-G households with an income less than £31,000. This cap
	applies irrespective of the property size, composition, or region.
Route 2:	EPC bands E-G households that meet a combination of two of the following proxies:
	Route 2 - Proxy 1) Homes in England in Lower-layer Super Output
	Area 1-3 (LSOA) *(see note below).
	Route 2 - Proxy 2) Householders receiving a Council Tax rebate
	reduction. (Rebates based on low income only, excludes single
	person rebates).
	Route 2 - Proxy 3) Householders vulnerable to living in a cold home
	as identified in the National Institute for Health and Care Excellence
	(NICE) Guidance. Only one from the list can be used , excludes the
	proxy 'low income' * (see note below).
	Route 2 - Proxy 4) A householder receiving free school meals due to
	low-income.
	Route 2 - Proxy 5) A householder supported by a LA run scheme,
	that has been named and described by the LA as supporting low
	income and vulnerable households for the purposes of NICE Guideline. Solihull is not currently referring under this proxy, we will
	look to develop this in the future based on need identified.
	Route 2 - Proxy 6)* A household referred to the LA for support by
	their energy supplier or Citizen's Advice, because they have been
	identified as struggling to pay their electricity and gas bills.
	Route 2 - Proxy 7) Non pre-payment households in debt for 13
	weeks or more and in a debt-repayment plan with their supplier or
	repaying their fuel debt through third party deductions.
	Route 2 - Proxy 8) Pre-payment meter households who have been
	self-disconnected (due to low income) or received discretionary/friendly credit in the last 13 weeks, or in a debt-
	repayment plan with their supplier or repaying their fuel debt through
	3rd party deductions.
Route 3:	EPC bands D-G households that have been identified by their doctor or GP
	as low income and vulnerable, with an occupant whose health conditions
	may be impacted further by living in a cold home. These health conditions
	may be cardiovascular, respiratory, immunosuppressed, or limited mobility
	related.
	This is because the Council has identified a positive correlation between
	households who suffer from long-term health conditions and living off a low-
	income, with living in poorly insulated homes.
Route 4:	EPC band D-G households that are referred under Route 4: Bespoke
	Targeting. Suppliers and LAs can submit an application to BEIS where they
	have identified a low income and vulnerable household, who are not already
т.	eligible under the exiting routes.
NOTE:*	Route 2 Proxy's 1 & 3 cannot be used together for Route 2.
	Route 2 - Proxy 6 (energy debt) cannot be used in conjunction with proxy 7 and 8.
	Private rented homes differ and can receive assistance under flex routes 1-4
	if their property is EPC (SAP) rated E-G.

Declaration and evidence check confirmation

All potentially eligible households should apply through Act On Energy by contacting advice@actonenergy.org.uk, the Council or one of their approved ECO installers to ensure that they can either benefit from the scheme or be assessed for eligibility under any other relevant programme.
