PUBLIC PATH DIVERSION ORDER Highways Act 1980

PUBLIC FOOTPATH SL20A (PART), ARDEN ACADEMY, KNOWLE, SOLIHULL

This order is made by Solihull Metropolitan Borough Council (the Council) under section 119 of the Highways Act 1980 (the 1980 Act) because it appears to the Council that in the interests of the lessee of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The lessee has agreed to defray any compensation which becomes payable in consequence of the coming into operation of this order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Knowle Ward Members and Knowle Society have been consulted and Solihull Metropolitan Borough Council have consented to the making of this order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- The public right of way over the land situate at the northern edge of Arden Academy school site. Knowle and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up from date of confirmation of this order.
- There shall be from the date of confirmation of this order be a public footpath over the land situate at the far northern edge of Arden Academy school site, Knowle described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this order.
- 3 The rights conferred on the public under think order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Leads from Point A (Grid Ref; SP 41794,27634) at the north eastern edge of Arden Academy, Knowle off Milverton Road and heads in a north westerly direction, skirting closely around various school buildings via Point B (Grid Ref; SP 41787,27638) and then via Point C (Grid Ref; SP 41786,27638) along a tarmac path and past another school building near Station Road (B4101) to Point D (Grid Ref; SP 41783, 27640), a short distance off Station Road. The part of this public footpath number: (SL20A) is 128 metres and a width defined as 1.8m on the Definitive Statement.

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

Leads from Point A (Grid Ref. SP 41794,27634) at the north eastern edge of Arden Academy, Knowle off Milverton Road and heads in a north westerly direction but close to the northern edge of the school boundary, firstly passing near some small service buildings before joining a new tarmac route to be created at Point E (Grid Ref. SP 41792,27636) and proceeding north westerly via Point F (Grid Ref. SP 41792,27637) and then via a 1.8m gap in fence at Point G (Grid Ref. SP 41790,27640) and onto Point H (Grid Ref. SP 41785,27643) all along the new tarmac path before turning in a south westerly direction parallel with Station Road (B4101) and re-joining the existing footpath at Point D (Grid Ref. SP 41783, 27640). The part of this public footpath number: (SL20A) is 131 metres in length with a width of 1.8m.


