Grace Period Definition

No penalty charge is payable for the contravention where the vehicle has been left beyond the permitted parking period for a period not exceeding 10 minutes.¹

1. Introduction

This policy sets out the parking enforcement grace period given to motorists when parked in designated parking spaces both on street and in off-street car parks. It does not apply to Marks & Spencer's pay on foot car park on Poplar Road, Solihull.

Designated off-street parking operates in 19 surface and multi-storey car parks throughout the borough. Car park locations and the type of payment for parking required is detailed in section 4 of this policy.

In October 2014 the Council introduced a cashless parking solution for customers in all P&D and F&D car parks. This provides an alternative means for customers to pay for parking instead of using cash or debit/credit cards.

A F&D paper parking ticket must be obtained from a ticket machine in all car parks that have an option to park without charge for a set period of time as indicated by the tariff boards.

However, if a customer wishes to park for longer than the free parking period permits, they must purchase the total amount of time required from the ticket machine or through the cashless parking provider.

In this instance the customer's free parking period is deducted from the total price, e.g., a 4-hour parking ticket with 3 hours free parking will only cost the equivalent of 1 hour.

The F&D only option is not available through the cashless parking solution provider.

The cashless payment solution means that customers have an alternative way of paying for their parking either by using a smart phone application (parking app) or calling the customer service provider's contact centre. The car park location number is displayed on the parking ticket machine and the tariff board.

2. Grace Period

A grace period applies to on-street and off-street parking places provided under traffic orders, whether the period of parking is paid for or free.

Grace periods only apply to designated parking places where a person is permitted to park. A road with a restriction (for example, single yellow line) or prohibition (such as a double yellow line) is not a 'designated' parking place either during or outside of the period of the restriction or prohibition.

1.1. Observation

It is accepted that there are occasions where a grace period should be applied while a customer is obtaining the required parking ticket.

A CEO will record the grace period as an observation in their HHC used for issuing PCNs. This will serve as proof that a grace period was given before issuing.

Where a P&D or F&D ticket is not on display, or the ticket on display has expired, a CEO will not issue a PCN instantly and will apply a 10-minute grace period as legally required. Only when the grace period has elapsed will a PCN be issued.

In both instances, the CEO will evidence this by photographing a copy of the expired parking ticket on display or the absence of a ticket.

1.2. Appeals

If a registered keeper considers a PCN has been issued incorrectly, they can appeal in writing² to Parking Services, or by using SBMC's online self-service portal.

Further advice on the legislation governing parking enforcement and what grounds a PCN can be challenged on, can be found at PATROL³, which is the official Joint Committee of enforcement authorities managing parking and other restrictions across England and Wales outside London.

3. Civil Enforcement

SMBC has the responsibility as the Highway Authority for Solihull to manage the road network as defined by the TMA part 2 16⁴.

This means SMBC can implement parking places for the purpose of alleviating or preventing congestion by designating areas as parking places under the powers granted by the RTRA Part 4 section 32⁵.

Off-street car parking spaces are enforced by qualified CEOs. In the instance a vehicle is seen to be parked in contravention, a CEO has the authority to issue a PCN under the powers granted by the TMA Part 6⁶.

The most common contraventions that occur in an on and off-street parking places that require enforcement are listed in the table below.

A full list of contraventions that can be enforced in on and off-street parking places can be found on the PATROL website⁷.

Where a F&D ticket needs to be displayed, customers must obtain a physical ticket from the parking machines located adjacent to on-street parking places or within the car parks.

A physical P&D ticket can be purchased from a machine, but customers also have the option to pay for parking using the cashless solution.

Customers are required to ensure they have appropriate method of payment before parking.
