Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the relevant Electoral Registration Officer by 5pm on Thursday, 2 May 2024. The physical incapacity must have occurred after 5pm on Wednesday, 24 April 2024. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 24 April 2024.
