



Sub-borough data is available at a variety of levels. As well as the borough's 17 electoral wards, the majority of data is based on the standard Census geographies:

- Lower Super Output Areas (LSOAs) local neighbourhoods based on a minimum population of 1,000 and an average of 1,500 (134 in Solihull);
- Middle Layer Super Output Areas (MSOAs) containing an average of 7,200 persons (29 in Solihull).

# Summary

#### **About Solihull**

Solihull lies at the heart of the West Midlands motorway network, has excellent public transport connections with the Birmingham city conurbation and is linked to many overseas destinations through Birmingham International Airport.

There are 148,000 jobs located in Solihull with strengths in business services, transport and manufacturing. The borough benefits from a range of key economic assets such as Solihull town centre, the NEC complex, Jaguar Land Rover and Birmingham Business Parks.

Solihull is a largely affluent borough, characterised by above average levels of income and limited levels of poverty and deprivation. For instance:

- 73% of Solihull households own their own home compared to 62% for England and 64% for the West Midlands.
- The median annual wage of Solihull residents in full-time employment is 11% higher than the England average and 18% higher than that for the West Midlands.
- 13% of the Solihull working age population claim Universal Credit compared to 15% for England and 17% for the West Midlands.
- 14% of Solihull children aged 0-15 years live in a low income household compared to 20% for England and 27% for the West Midlands.
- The 2019 Index of Multiple Deprivation (IMD) shows that Solihull is the least deprived local authority in the West Midlands. Just 16% of the population live in one of the most deprived 20% of neighbourhoods in England, whereas 40% of people live in the least deprived 20%.

This is not the case for all Solihull communities and below average incomes and poverty is far more common among households in the three North Solihull wards (Smith's Wood; Kingshurst and Fordbridge; Chelmsley Wood). For instance:

- Just 47% of North Solihull households own their own home while 40% are social rented.
- 31% of the North Solihull working age population claim Universal Credit.
- 29% of North Solihull children aged 0-15 years live in a low income household.
- According to the IMD 52% of people in north Solihull live in one of the most deprived 20% of neighbourhoods in England, including 11% who live in the most deprived 5%.

#### **About Elmdon**

The Elmdon ward is located in the urban west of the Borough, south of Coventry Road and bordered by Lode Lane/Hobs Moat Road to the west. Alongside the Land Rover plant other notable features in the area include the "Green Flag" Elmdon Park and Birmingham International Airport and National Exhibition Centre in neighbouring Bickenhill ward. Elmdon, divided by the Land Rover plant, is not a homogenous community, with a significant north/south split between the area known as Elmdon Heath in the south and Elmdon in the north.


Although mostly urban, areas such as Coppice and Elmdon Park North in the east are somewhat more isolated at the edge of the conurbation, with greater distance to key services. The map illustrates the individual localities within Elmdon, based on the Office for National Statistics LSOAs. A number of LSOAs cross ward boundaries, most notably Coppice, which although by area falls mostly in the Bickenhill ward, has its greatest population concentration in Elmdon.

# **Population and Households**

#### Population Size and Growth


The 2021 Census shows that 12,322 people live in Elmdon, representing 2,461 people per km<sup>2</sup> (Population density Solihull 1,213 and England 434 per km<sup>2</sup>). Elmdon has the 7<sup>th</sup> smallest population density of Solihull's 17 wards.

# Solihull Population Density 2021



Between 2011 and 2021 the Elmdon population increased by 255 people. This equates to growth of 2.1% over this 10-year period; much lower than the Solihull (4.6%) and England (6.6%) averages. Population growth in Elmdon was the 5<sup>th</sup> lowest out of Solihull's 17 wards.

## Solihull Population Growth 2011 - 2021




#### **Population Age Groups**

18% of the Elmdon population are under 16 years of age (including 7% aged 5 and under), 60% are working age and 21% are aged 65 and over (including 3% aged 85+).

The size of the under 16 population in Elmdon (18%) is smaller than Solihull (19%) or England (19%), while the number aged 65+ is proportionally larger than England and in line with Solihull (21% Elmdon, 21% Solihull, 18% England).

# Age Structure in Elmdon




In the 10-years 2011 to 2021 population growth in Elmdon has been driven by those aged 25-34 (+11% growth) and those aged 50 and over (+8% growth aged 50-64, +5% aged 65+). This has been partially offset by population decline among those aged 35-49.

Comparing 10-year population growth for Elmdon and England shows a significant difference among older people aged 65+ (+5% Elmdon, +20% England). The population aged 35-64 years in Elmdon decreased over this period in contrast to an increase across England (-2% Elmdon; +5% England).

# % Change in Population in Elmdon by Age Group 2011 - 2021




#### **Ethnicity**

80% of the Elmdon population are white and 20% from an ethnic minority background. Elmdon has a proportionally larger ethnic minority population than either Solihull (18%) or England (19%). 68% of the ethnic minority population in Elmdon are Asian/Asian British, with this group representing 14% of all people in Elmdon.

# Ethnic Minority Population in Solihull 2021




The ethnic minority population in Elmdon is proportionally higher among younger than older age groups. For instance, 28% of those under 25 are from an ethnic minority background compared to just 7% of those aged 65+.

The pattern in Elmdon is the same as England, with the ethnic minority population higher among younger age groups in both. A sharp reduction in the ethnic minority population from the age of 50 onwards is evident in both Elmdon and England.

# Ethnic Minority Population by Age in Elmdon 2021




In the 10-years 2011 to 2021 the proportion of Elmdon residents from an ethnic minority background increased from 12% to 20% of the population.

Although the Elmdon population increased by just over 2%, the number of ethnic minority residents increased by 70% (1,011 individuals) in the 10 years to 2021. This was largely offset by a fall of -7% (-749 individuals) in the number of white residents. In absolute terms the increase in Elmdon residents was largest among those from an Asian/Asian British background (+614 individuals) followed by those from the other ethnic group (+152).

Growth of 70% in the ethnic minority population in Elmdon in the 10 years to 2021 is higher than the England average (38%) but is slightly smaller than that for Solihull (+72%). Growth in the ethnic minority population in Elmdon is 8<sup>th</sup> lowest among Solihull's 17 wards.

#### <u>Religion</u>

67% of the Elmdon population who answered the Census religious identification question said that they had a religious faith, with 33% saying they are had no religion. Elmdon has proportionally people with no religion than either Solihull (35%) or England (39%).

Like Solihull and England as a whole, Christianity is the most common religious faith in Elmdon (52%). A notable feature of the Elmdon religious profile is the relatively large number of Muslims in the ward (8% Elmdon, 6% Solihull, 7% England), although Hindus and Sikhs are also more common than in the benchmarks.

#### Origin and Language


At the time of the 2021 Census, around 92% of the Elmdon population lived at the same address that they were resident in a year before. Of the remainder, most migrants lived elsewhere in the UK (94% of Elmdon migrants, 7% of Elmdon population) with a small number coming from outside UK (6% of Elmdon migrants, 0.5% of Elmdon population).


88% of the Elmdon population were born in the UK (90% Solihull, 83% England). Nearly 12% of the Elmdon population were born overseas (1,446 individuals). Proportionally Elmdon has the 7<sup>th</sup> highest overseas born population in Solihull.

# Population Born Overseas in Solihull 2021



49% of the Elmdon population born overseas were born in the middle East or Asia (715 individuals), with 32% born in another European country (462 individuals), 13% (184) in Africa and 5% (71) in the Americas & Caribbean.



The Census data shows that compared to England a relatively small proportion of those born overseas have arrived since 2014 (25% Elmdon; 34% England). By contrast more have been long domiciled in the UK, with 26% arriving prior to 1981 compared to 14% across England.

#### <u>Households</u>


There are 5,117 households in Elmdon, with family households comprising 66% (3,359) and single person households 29% (1,475). Elmdon's household profile is the same as Solihull's with a slightly larger proportion of family households than England (66% Elmdon; 63% England).


# Households with Dependent Children in Solihull 2021


# Single Parent Households with Dependent Children in Solihull 2021



The number of households in Elmdon occupied by older people is higher than the England average and in line with that of Solihull (26% Elmdon; 22% England). 
# Single Older People Households in Solihull 2021



# **Deprivation, Benefits and Poverty**

For much of 2022 and 2023 UK households have been subject to high levels of inflation and a squeeze on living standards. This is reflected in local survey results, with 70% of respondents to the 2022 Place Survey saying that they were more worried about their finances than a year previously. This pattern was replicated across all three Solihull localities.

#### Index of Multiple Deprivation

The Index of Multiple Deprivation (IMD) is the official measure of deprivation in England produced by the Ministry of Housing Communities and Local Government (MHCLG). The IMD combines 39 economic, financial, social, environmental and housing measures into a single deprivation score for individual neighbourhoods called Super Output Areas (LSOAs) in England. There are 32,844 LSOAs in England and 134 in Solihull with an average population of 1,500.

The IMD therefore allows each LSOA neighbourhood to be ranked relative to one another according to their level of deprivation.

The 2019 IMD shows that Solihull is the least deprived upper tier Local Authority in the West Midlands and is ranked in the 2<sup>nd</sup> top quintile nationally.


Solihull is relatively polarised between large parts of the borough that rank among the least deprived areas of England and a concentration of neighbourhoods in North Solihull among the most deprived.



Deprivation is substantially higher in the North Solihull wards of Chelmsley Wood, Kingshurst & Fordbridge and Smith's Wood than elsewhere in the borough. The deprivation evident in North Solihull is part of a wider area of disadvantage that spreads throughout east Birmingham.

Elmdon's nine LSOAs are, on average, ranked on the 59<sup>th</sup> percentile nationally, with the 17 Solihull wards ranging from the deprived Chelmsley Wood (9<sup>th</sup> percentile) to the advantaged St Alphege (94<sup>th</sup> percentile). On this basis Elmdon would be considered in the middle of areas in England. However, in a relatively advantaged borough like Solihull, Elmdon is towards the more deprived end of the scale, particularly for wards in the south of the borough.

Deprivation among the nine Elmdon LSOAs ranges from the most deprived neighbourhood Land Rover North on the 47<sup>th</sup> percentile to the least deprived neighbourhood Elmdon Heath on the 83<sup>rd</sup> percentile.

There is little evidence of significant deprivation in any Elmdon neighbourhood, although some, such as Land Rover North, Coppice and Damsonwood South, are more disadvantaged than other south Solihull LSOA.


#### **Universal Credit**

As of July 2023 914, Elmdon residents were claiming Universal Credit (UC), equating to 11.9% of the working age population. The rate in Elmdon is lower than that for Solihull (12.7%) or England (14.7%).

40% of the UC in Elmdon are in employment and 60% are not in employment, this is broadly in-line with the Solihull and England averages.


## Universal Credit Claimant Rate in Solihull July 2023



#### **Child Poverty**

At the end of 2021/22 307 children aged 0-15 years in Elmdon lived in a low income household. This equates to 13% of the 0-15 population, lower than both the Solihull (15%) and England (20%) averages. The rate in Elmdon is the 7<sup>th</sup> highest among Solihull's 17 wards which range from 30% in Smith's Wood to 4% in St Alphege.

Children aged 0 - 15 years in a low-income household in Solihull 2021/22




The number of children living in a low-income household in Elmdon varies between age group, with a relatively small proportion aged 0-4 years (26% vs 28% England) and a larger number aged 11-15 years (43% vs 35% England).

There was a substantial rise from 243 at the end of 2018/19 to 292 at the end of 2019/20 coinciding with the onset of the outbreak of covid-19. This rise is consistent with those across Solihull and England.

Elmdon's nine LSOAs are, on average, ranked on the 60<sup>th</sup> percentile nationally of the IDACI, with the 17 Solihull wards ranging from the deprived Smith's Wood (6<sup>th</sup> percentile) to the advantaged St Alphege (89<sup>th</sup> percentile). On this basis Elmdon would be considered in the middle for child income deprived areas in England. However, in a relatively advantaged borough like Solihull, Elmdon is towards the more deprived end of the scale, particularly for wards in the south of the borough.



#### Older People Poverty

In February 2023 there were 252 older people in Elmdon claiming a pension credit. This equates to 9% of the pension age population. This is in line with the Solihull (9%) average and lower than the England (11%) average. Elmdon has the 6<sup>th</sup> highest pension credit rate among Solihull's 17 wards.

Elmdon's nine LSOAs are, on average, ranked on the 59<sup>th</sup> percentile nationally of the IDAOP, with the 17 Solihull wards ranging from Chelmsley Wood (21<sup>st</sup> percentile) to St Alphege (93<sup>rd</sup> percentile). It is notable that even the most relatively deprived Solihull wards rank outside the most deprived quintile in England on this measure. Six Solihull wards rank as more deprived than Elmdon in terms of income deprivation affecting older people and ten as less deprived.



#### **Fuel Poverty**

Fuel poverty is measured by the Department for Business, Energy & Industrial Strategy which determines that those households which are below the poverty line and at the same time are energy inefficient and fuel poor.

688 Elmdon households were classified as fuel poor in 2021. This equates to 11.2% of all Elmdon households, slightly lower than the Solihull (12.7%) and England (13.1%) averages. Among the 17 Solihull wards Elmdon has the 5<sup>th</sup> lowest fuel poverty rate.


At the time of the 2021 Census 74% of the Elmdon working age population were in employment (5,554 individuals), 4% were unemployed (320 individuals) and 21% economically inactive (1,591 individuals). 
# Unemployment Rate in Solihull March 2021



#### **Resident Employment**




## Employed in Public Services in Solihull March 2021




#### **Claimant Count Unemployment**

As of August 2023, 220 people in Elmdon were in receipt of unemployment benefit. This equates to a claimant unemployment rate of 2.9%, lower than the Solihull (3.2%) and England (3.8%) averages. Among the 17 Solihull wards the claimant unemployment rate in Elmdon is the 6<sup>th</sup> highest.

The claimant unemployment has fluctuated over recent years following the onset on the Covid-19 pandemic in early 2020. 
#### **Resident Qualifications**

Working age Elmdon residents tend to have higher levels of formal qualifications then the benchmarks. For instance, 22% of Elmdon residents (1,630 individuals) had NVQ level 3 qualifications in March 2021 compared to 19% of the Solihull population and 20% of people in England. However, only 36% of Elmdon residents (2,668) have NVQ level 4+ qualifications in March 2021 compared to 40% of the Solihull population and 37% of the England population.

At the other end of the spectrum fewer Elmdon residents aged 16-64 have no qualifications (9% vs 11% Solihull, 12% England) than benchmark averages.

# Formal Qualification Levels in 2021 16 - 64 Population Elmdon








# Life Limited a Lot by Long – Term Health Condition Solihull Population 2021







#### Life Expectancy





## Female Life Expectancy in Solihull 2016 to 2020





Standardised Admissions Ratio





Standardised Admissions Ratio





## All Premature & Preventable Deaths 2016 to 2020





## Households Living in a Flat in Solihull 2021




## **Tenure**

#### Overcrowding

Household overcrowding is assessed by comparing the number of people in a household against the number of bedrooms that they require based on the bedroom standard which determines that adults, children over 16 and children between 10 and 15 of a different sex are entitled to their own bedroom. Overcrowding occurs when the number of bedrooms in the accommodation is less than the number required under this bedroom standard.



(Based on Number of Bedrooms)




## Access to Car or Van

## Households with access to a car or van in Solihull 2021



## **Community Satisfaction and Belonging**

Most Solihull respondents to the 2022 Place Survey say that they are satisfied with their local area as a place to live (84%) with just 10% saying that they are dissatisfied. 
## Satisfaction with local area as place to live


## How has local area changed in last 2 years




To what extent does respondent feel they belong to local neighbourhood




# To what extent do feel able to influence decisions that affect your local area



Participation is higher outside North Solihull with a participation rate of 36% in West Solihull.

On average 57% of respondents to the 2022 Solihull Place Survey say that they have provided informal help in their local community or to a neighbour over the last year, including 32% who have done so at least once a month. Participation is higher outside North Solihull with a participation rate of 61% in West Solihull.






## **Community Safety**

59% of Solihull respondents to the 2022 Place Survey say that they feel safe after dark whereas 27% feel unsafe. There is a significant difference between North Solihull and the rest of the borough on this measure, with 61% of West Solihull residents feeling safe after dark.


## Feeling safe after dark in local area



Respondents to the 2022 Solihull Place Survey were asked which of 10 types of antisocial behaviour were a problem in their local area. The most commonly cited problem in West Solihull was vehicle nuisance (30% of respondents) followed by rubbish & litter (29%) and vandalism (22%). Each type of ASB was considered a problem by fewer West Solihull respondents than the Solihull average.

## **Crime Deprivation**

Elmdon's nine LSOAs are, on average, ranked on the 62<sup>nd</sup> percentile nationally in terms of crime & disorder deprivation, with the 17 Solihull wards ranging from the crime & disorder deprived Kingshurst & Fordbridge (15<sup>th</sup> percentile) to the advantaged Knowle (85<sup>th</sup> percentile). There are few signs of significant crime deprivation in Elmdon and in Solihull there are eight more deprived wards and eight less deprived wards.

Crime & disorder deprivation among the nine Elmdon LSOAs ranges from Hatchford Brook on the 38<sup>th</sup> percentile to the least deprived neighbourhood Land Rover North on the 99<sup>th</sup> percentile. Only three Elmdon neighbourhoods are in the most crime deprived 50% of LSOAs in England (Hatchford Brook, Land Rover South and Coppice).



## Reported Crime and Antisocial Behaviour

The table below shows the number of recorded crimes in the year to date (January-November 15<sup>th</sup> 2023). There have been 669 crimes in Elmdon, 4.1% of the Solihull total and equating to 52.5 per 1,000 population. This is lower than the Solihull average of 74.7 per 1,000 and the 6<sup>th</sup> lowest of the 17 Solihull wards.

## Annual Reported Number of Crimes in Elmdon



The table below shows the number of recorded antisocial behaviour (ASB) incidents in the year to date (January-November 15<sup>th</sup>, 2023). There have been 110 ASB incidents in Elmdon, 9.4% of the Solihull total and equating to 8.6 per 1,000 population. This is higher than the Solihull average of 5.4 per 1,000 and ranks Elmdon 2<sup>nd</sup> highest of the 17 Solihull wards.
