



Sub-borough data is available at a variety of levels. As well as the borough's 17 electoral wards, the majority of data is based on the standard Census geographies:

- Lower Super Output Areas (LSOAs) local neighbourhoods based on a minimum population of 1,000 and an average of 1,500 (134 in Solihull);
- Middle Layer Super Output Areas (MSOAs) containing an average of 7,200 persons (29 in Solihull).

### Summary

### **About Solihull**

Solihull lies at the heart of the West Midlands motorway network, has excellent public transport connections with the Birmingham city conurbation and is linked to many overseas destinations through Birmingham International Airport.

There are 148,000 jobs located in Solihull with strengths in business services, transport and manufacturing. The borough benefits from a range of key economic assets such as Solihull town centre, the NEC complex, Jaguar Land Rover and Birmingham Business Parks.

Solihull is a largely affluent borough, characterised by above average levels of income and limited levels of poverty and deprivation. For instance:

- 73% of Solihull households own their own home compared to 62% for England and 64% for the West Midlands.
- The median annual wage of Solihull residents in full-time employment is 11% higher than the England average and 18% higher than that for the West Midlands.
- 13% of the Solihull working age population claim Universal Credit compared to 15% for England and 17% for the West Midlands.
- 14% of Solihull children aged 0-15 years live in a low income household compared to 20% for England and 27% for the West Midlands.
- The 2019 Index of Multiple Deprivation (IMD) shows that Solihull is the least deprived local authority in the West Midlands. Just 16% of the population live in one of the most deprived 20% of neighbourhoods in England, whereas 40% of people live in the least deprived 20%.

This is not the case for all Solihull communities and below average incomes and poverty is far more common among households in the three North Solihull wards (Smith's Wood; Kingshurst and Fordbridge; Chelmsley Wood). For instance:

- Just 47% of North Solihull households own their own home while 40% are social rented.
- 31% of the North Solihull working age population claim Universal Credit.
- 29% of North Solihull children aged 0-15 years live in a low income household.
- According to the IMD 52% of people in north Solihull live in one of the most deprived 20% of neighbourhoods in England, including 11% who live in the most deprived 5%.

### **About Shirley East**

The Shirley East ward is located in the urban west of the Borough, bordered by Birmingham to the north and Stratford Road to the west. In many respects these two boundaries are the most significant influences on the ward's economic and social conditions. Stratford Road provides a commercial hub and access to local Solihull and Birmingham job markets, while at the same time generating traffic congestion and acting as a minor crime and anti-social behaviour conduit. Green Hill is a focus for many of the social and economic problems apparent along this Stratford Road/Birmingham border axis, with relatively severe and worsening deprivation levels affecting children and older people a major concern. To the south and east of Stratford Road prosperity levels are much higher, with much more advantaged educational, health and crime levels apparent.


The map on page 2 illustrates the individual localities within Shirley East, based on the Office for National Statistics LSOAs. LSOAs often cross ward boundaries, with Shirley Heath overlapping the Shirley East and South wards.

### Population Size and Growth


The 2021 Census shows that 12,017 people live in Shirley East, representing 4,714 people per km<sup>2</sup> (Population density Solihull 1,213 and England 434 per km<sup>2</sup>). Shirley East has the 5<sup>th</sup> largest population density of Solihull's 17 wards.

### Solihull Population Density 2021



Between 2011 and 2021 the Shirley East population increased by 350 people. This equates to growth of 3% over this 10-year period much lower than the Solihull (4.6%) and England (6.6%) averages. Population growth in Shirley East was the 10<sup>th</sup> highest out of Solihull's 17 wards.

### Solihull Population Growth 2011 - 2021




### **Population Age Groups**

20% of the Shirley East population are under 16 years of age (including 6% aged 5 and under), 59% are working age and 20% are aged 65 and over (including 4% aged 85+).

The age profile in Shirley East is similar to the England average. The most notable difference is the relative dearth of young adults aged 16-34 years in Shirley East (19% vs 24% for England).


### Age Structure in Shirley East




In the 10-years 2011 to 2021 population growth in Shirley East has been driven by those aged 25-34 and those aged 50 and over (+20% growth aged 25-34, +17% growth aged 50-64, +4% aged 65+). This has largely been offset by population decline among young people under 25 years and by those aged 35-49.

The 10-year population growth profile in Shirley East is similar to England. The most notable difference is relatively lower growth in Shirley East among those aged 65 and over (+3% Shirley East; +20% England).






### **Ethnicity**

71% of the Shirley East population are white and 29% from an ethnic minority background. Shirley East has a proportionally larger ethnic minority population than either Solihull (18%) or England (19%). 74% of the ethnic minority population in Shirley East are Asian/Asian British, with this group representing 22% of all people in Shirley East.

Shirley East has the largest ethnic minority population and largest Asian/Asian British population among Solihull's 17 wards.


### Ethnic Minority Population in Solihull 2021



The ethnic minority population in Shirley East is proportionally higher among younger than older age groups. For instance, 40% of those under 25 are from an ethnic minority background compared to just 9% of those aged 65+.

The pattern in Shirley East is the same as in England, with the ethnic minority population higher among younger age groups in both. A sharp reduction in the ethnic minority population from the age of 50 onwards is evident in both Shirley East and England.




In the 10-years 2011 to 2021 the proportion of Shirley East residents from an ethnic minority background increased from 17% to 29% of the population.

Although the Shirley East population increased by just 3% the number of ethnic minority residents increased by 79% (1,549 individuals) in the 10 years to 2021. This was partially offset by a fall of -12% (-1,194 individuals) in the number of white residents. In absolute terms the increase in Shirley East residents was largest among those from an Asian/Asian British background (+1,073 individuals) followed by the other ethnic group population (+214).

Growth of 79% in the ethnic minority population in Shirley East in the 10 years to 2021 is higher than the England (38%) and Solihull (+72%) averages. Growth in the ethnic minority population in Shirley East is 7<sup>th</sup> highest among Solihull's 17 wards.

### <u>Religion</u>

72% of the Shirley East population who answered the Census religious identification question said that they had a religious faith, with 28% saying they had no religion. Shirley East has proportionally fewer people with no religion than either Solihull (35%) or England (39%).

Like Solihull and England as a whole, Christianity is the most common religious faith in Shirley East (50%). A notable feature of the Shirley East religious profile is the relatively large number of Muslims in the ward (10% Shirley East, 6% Solihull, 7% England), although Hindus and Sikhs are also more common than in the benchmarks.

### Origin and Language


At the time of the 2021 Census, around 92% of the Shirley East population lived at the same address that they were resident in a year before. Of the remainder, most migrants lived elsewhere in the UK (90% of Shirley East migrants, 7% of Shirley East population) with a small number coming from outside UK (10% of Shirley East migrants, 0.8% of Shirley East population).



### Population Born Overseas in Solihull 2021



57% of the Shirley East overseas born population were born in the middle East or Asia (980 individuals), with 20% born in another European country (352 individuals), 17% (293) in Africa and 4% (73) in the Americas & Caribbean.

The Census data shows that while a relatively large proportion of the Shirley East population were born overseas, the number of arrivals since 2014 is much lower than the England average (21% Shirley East; 34% England). By contrast, a much larger proportion of the Shirley East overseas born population arrived before 1981 (31% Shirley East; 14% England).

### **Households**


There are 4,778 households in Shirley East, with family households comprising 67% (3,192) and single person households 28% (1,327). Compared with the England and Solihull averages Shirley East has slightly fewer single person households and more family households.

### Households with Dependent Children in Solihull 2021




Single parent households represent 10% of all households (486 households) in Shirley East compared to over 11% across Solihull and England.

About 56% of single parent households in Shirley East contain dependent children. The proportion of single parent households with dependent children is considerably lower than both the Solihull and England averages (5.7% Shirley East; 7.2% Solihull; 6.9% England).


## Single Parent Households with Dependent Children in Solihull 2021



Although the pattern is the same as Solihull as a whole, more households in Shirley East are occupied by older people than across England (26% Shirley East; 22% England). Shirley East has a larger proportion of both older couple households and single older people households than the England average. Shirley East has 738 single older people households and at 15% is the 9<sup>th</sup> highest proportion in Solihull.


## Single Older People Households in Solihull 2021



### **Deprivation, Benefits and Poverty**

For much of 2022 and 2023 UK households have been subject to high levels of inflation and a squeeze on living standards. This is reflected in local survey results, with 70% of respondents to the 2022 Place Survey saying that they were more worried about their finances than a year previously. This pattern was replicated across all three Solihull localities.

### Index of Multiple Deprivation

The Index of Multiple Deprivation (IMD) is the official measure of deprivation in England produced by the Ministry of Housing Communities and Local Government (MHCLG). The IMD combines 39 economic, financial, social, environmental and housing measures into a single deprivation score for individual neighbourhoods called Super Output Areas (LSOAs) in England. There are 32,844 LSOAs in England and 134 in Solihull with an average population of 1,500.

The IMD therefore allows each LSOA neighbourhood to be ranked relative to one another according to their level of deprivation.

The 2019 IMD shows that Solihull is the least deprived upper tier Local Authority in the West Midlands and is ranked in the 2<sup>nd</sup> top quintile nationally.


Solihull is relatively polarised between large parts of the borough that rank among the least deprived areas of England and a concentration of neighbourhoods in North Solihull among the most deprived.



Deprivation is substantially higher in the North Solihull wards of Chelmsley Wood, Kingshurst & Fordbridge and Smith's Wood than elsewhere in the borough. The deprivation evident in North Solihull is part of a wider area of disadvantage that spreads throughout east Birmingham.



Shirley East's eight LSOAs are, on average, ranked on the 75<sup>th</sup> percentile nationally, with the 17 Solihull wards ranging from the deprived Chelmsley Wood (9<sup>th</sup> percentile) to the advantaged St Alphege (94<sup>th</sup> percentile). On this basis Shirley East would be considered one of the least deprived areas in England.

Deprivation among the eight Shirley East LSOAs ranges from the most deprived neighbourhood Green Hill on the 14<sup>th</sup> percentile to the least deprived neighbourhood Streetsbrook on the 99<sup>th</sup> percentile.

The majority of Shirley East LSOAs are among the least deprived 25% if neighbourhoods in England. However, Green Hill represents an isolated pocket of relative deprivation and is the 2<sup>nd</sup> most deprived neighbourhood in south Solihull.


### **Universal Credit**

As of July 2023, 599 Shirley East residents were claiming Universal Credit (UC), equating to 8.4% of the working age population. The rate in Shirley East is lower than that for Solihull (12.7%) or England (14.7%).

38% of the UC in Shirley East are in employment and 62% not in employment, this is broadly in-line with the Solihull and England averages.




### Universal Credit Claimant Rate in Solihull July 2023



### **Child Poverty**

At the end of 2021/22 237 children aged 0-15 years in Shirley East lived in a low income household. This equates to 9% of the 0-15 population, lower than both the Solihull (15%) and England averages (20%). The rate in Shirley East is the 7<sup>th</sup> Lowest among Solihull's 17 wards which range from 30% in Smith's Wood to 4% in St Alphege.





The number of children living in a low-income household in Shirley East varies between age group. A relatively small proportion of the total in Shirley East were aged 0-4 years (19% Shirley East; 28% England), while proportionally more were older children aged 11-15 years (46%. Shirley East; 35% England).

The number of Shirley East children living in a low-income household averaged 233 in the six years 2016/17 to 2021/22. There was a rise from 224 at the end of 2018/19 to 257 at the end of 2019/20 coinciding with the onset of the outbreak of covid-19. This rise is consistent with those across Solihull and England. The number of Shirley East children living in a low income household edged downwards from 2018/19 to 2021/22.

The Income Deprivation Affecting Children Index (IDACI) is a component part of the IMD measuring the relative income deprivation impacting upon children aged 0-15 years.

Shirley East's eight LSOAs are, on average, ranked on the 71<sup>st</sup> percentile nationally of the IDACI, with the 17 Solihull wards ranging from the deprived Smith's Wood (6<sup>th</sup> percentile) to the advantaged St Alphege (89<sup>th</sup> percentile). On this basis Shirley East would be considered one of the least income deprived areas in England for children.



### Older People Poverty

In February 2023 there were 200 older people in Shirley East claiming a pension credit. This equates to 8% of the pension age population lower than both the Solihull (9%) and England (11%) averages. Shirley East has the 8<sup>th</sup> highest pension credit rate among Solihull's 17 wards.

The Income Deprivation Affecting Older People (IDAOP) is a component part of the IMD measuring the relative income deprivation impacting upon older people aged 65 and over.

Shirley East's eight LSOAs are, on average, ranked on the 65<sup>th</sup> percentile nationally of the IDAOP, with the 17 Solihull wards ranging from Chelmsley Wood (21<sup>st</sup> percentile) to St Alphege (93<sup>rd</sup> percentile). It is notable that even the most relatively deprived Solihull wards rank outside the most deprived quintile in England on this measure. In Solihull, Shirley East is in the middle, with eight wards ranking as more deprived and eight less deprived in terms of income deprivation affecting older people.

Older people income deprivation among the eight Shirley East LSOAs ranges from Green Hill on the  $21^{\text{st}}$  percentile to the least deprived neighbourhood Blossomfield North on the  $92^{\text{nd}}$  percentile.

There are few signs of substantial deprivation among the Shirley East neighbourhoods. However, Green Hill and Stratford Road South-East are among the most deprived older people income neighbourhoods in south Solihull.



### **Fuel Poverty**

Fuel poverty is measured by the Department for Business, Energy & Industrial Strategy which determines that those households which are below the poverty line and at the same time are energy inefficient and fuel poor.

648 Shirley East households were classified as fuel poor in 2021. This equates to 12.1% of all Shirley East households, slightly lower than the Solihull (12.7%) and England (13.1%) averages. Among the 17 Solihull wards Shirley East has the 9<sup>th</sup> highest fuel poverty rate.

### Resident Economic Activity


At the time of the 2021 Census 76% of the Shirley East working age population were in employment (5,403 individuals), 3% were unemployed (244 individuals) and 21% economically inactive (1,501 individuals). This was more positive than both the Solihull and England averages where employment was less common and economic activity higher.

### Unemployment Rate in Solihull March 2021




### Resident Employment


### Occupation of Employed Population Shirley East 2021


### Employed in Public Services in Solihull 2021




### **Claimant Count Unemployment**

As of August 2023, 185 people in Shirley East were in receipt of unemployment benefit. This equates to a claimant unemployment rate of 2.6%, lower than the Solihull (3.2%) and England (3.8%) averages. Among the 17 Solihull wards the claimant unemployment rate in Shirley East is the 9<sup>th</sup> highest.

The claimant unemployment has fluctuated over recent years following the onset on the Covid-19 pandemic in early 2020. Claimant unemployment in Shirley East has been consistently lower than England but rose from 1.7% in August 2019 to 4.5% a year later. It has subsequently trended downwards, albeit with a small uptick between August 2022 and 2023 (from 2.2% to 2.6%).




### **Resident Qualifications**

Working age Shirley East residents tend to have higher levels of formal qualifications then the benchmarks. For instance, 46% of Shirley East residents (3,321 individuals) had NVQ level 4+ qualifications in March 2021 compared to 40% of the Solihull population and 37% of people in England.

At the other end of the spectrum fewer Shirley East residents aged 16-64 have either no qualifications (7% vs 11% Solihull, 12% England) or NVQ level 1 qualifications (8% vs 10% Solihull, 10% England) than benchmark averages.

### Formal Qualification Levels 2021 16 - 64 Population in Shirley East






### General Health of Population Shirley East 2021


# Disability in Population Shirley East 2021


### Life Limited a Lot by Long – Term Health Condition Solihull Population 2021



### Life Expectancy



Life expectancy in Shirley East is statistically significantly higher than the England average for both males and females<sup>i</sup>.



### Female Life Expectancy in Solihull 2016 to 2020




#### **Hospital Admissions**


### Emergency Hospital Admissions 2016/17 to 2020/21

### Admissions for Alcohol 2016/17 to 2020/21







Standardised Mortality Ratio



Standardised Mortality Ratio





### Households Living in a Flat in Solihull 2021




#### **Tenure**

#### Overcrowding

Household overcrowding is assessed by comparing the number of people in a household against the number of bedrooms that they require based on the bedroom standard which determines that adults, children over 16 and children between 10 and 15 of a different sex are entitled to their own bedroom. Overcrowding occurs when the number of bedrooms in the accommodation is less than the number required under this bedroom standard.


A large majority of households in Shirley East have at least one spare bedroom and are considered under-utilised (76%, 3,623 households). This is common across Solihull and England. Just 2% of Shirley East households are overcrowded compared to the England average of 4%.

(Based on Number of Bedrooms)




### Access to Car or Van



### Community Satisfaction and Belonging


Most Solihull respondents to the 2022 Place Survey say that they are satisfied with their local area as a place to live (84%) with just 10% saying that they are dissatisfied. Levels of satisfaction are high across all three Solihull localities and in West Solihull 88% are satisfied and 7% dissatisfied.

## Satisfaction with local area as place to live





## How has local area changed in last 2 years











### **Civic Participation**


# To what extent do feel able to influence decisions that affect your local area



Despite the fact that 57% of respondents to the 2022 Solihull Place Survey say that they can't influence local decisions only 36% say that they would definitely like more involvement with 33% saying that they definitively don't want to be involved. 




# Have taken part in formal volunteering in last year






### **Community Safety**


## Feeling safe after dark in local area

The most commonly cited problem in West Solihull was vehicle nuisance (30% of respondents) followed by rubbish & litter (29%) and vandalism (22%). Each type of ASB was considered a problem by fewer West Solihull respondents than the Solihull average.

### **Crime Deprivation**

Shirley East's eight LSOAs are, on average, ranked on the 65<sup>th</sup> percentile nationally in terms of crime & disorder deprivation, with the 17 Solihull wards ranging from the crime & disorder deprived Kingshurst & Fordbridge (15<sup>th</sup> percentile) to the advantaged Knowle (85<sup>th</sup> percentile). On this basis Shirley East would be considered broadly in-line with both England and Solihull which has ten more deprived wards and six less deprived wards.

Crime & disorder deprivation among the eight Shirley East LSOAs ranges from Green Hill on the 15<sup>th</sup> percentile to the least deprived neighbourhood Sharmans Cross South on the 94<sup>th</sup> percentile. Only Green Hill is in the most deprived 40% of neighbourhoods in England and there is a substantial gap between Green Hill and the next most deprived neighbourhood in Shirley East on this measure (Shirley Heath 51<sup>st</sup> percentile), showing the extent to which crime deprivation (such as it is) in Shirley East is concentrated in one small area.


### Reported Crime and Antisocial Behaviour

The table below shows the number of recorded crimes in the year to date (January-November 15<sup>th</sup> 2023). There have been 724 crimes in Shirley East, 4.5% of the Solihull total and equating to 59.7 per

1,000 population. This is lower than the Solihull average of 74.7 per 1,000 and the  $8^{th}$  lowest of the 17 Solihull wards.

### Annual Reported Number of Crimes in Shirley East



There have been 33 ASB incidents in Shirley East, 2.8% of the Solihull total and equating to 2.7 per 1,000 population.
