

### 1. Background

1.1. The HS2 Road Safety Fund allocation aims to facilitate highway improvement schemes that will contribute to a lasting road safety legacy in areas affected by or near the HS2 corridor. Station Road, Marston Green was identified as a site that would benefit from the installation of a new raised zebra crossing facility to aid pedestrians crossing the road on route to and from local schools, amenities and transport links including Marston Green Train Station. The location can be seen below in Figure 1.1.

- 1.2. The proposals as advertised are detailed in the consultation plan in Appendix A.
- 1.3. The proposals as advertised in the legal notice in Appendix B.

### 2. Representations for Consideration

- 2.1. The proposals were formally advertised on 18 April 2025 and the closing date for the receipt of representations was 09 May 2025.
- 2.2. One representation was received however it is important to note that the respondent stated that they did not object to the scheme but provided feedback and offered suggestions regarding the vertical traffic calming measures proposed.
- 2.3. The response to the single representation can be seen below.



Representation/Issue	Supporting Commentary	
1 – Speed of traffic and type of vertical traffic calming measure	One representation was received regarding the speed of which the current traffic is travelling down Station Road and a request that any new vertical traffic calming measures installed will be full width and not speed cushions.	
Officers Comments/Response The authority can confirm that the raised road hump that will be installed at this location will be a full width hump and therefore it is expected that as well as improving road safety through the improvements to		
pedestrian accessibility, it will also help to mitigate vehicle speeds on the approaches to the proposed cross facility.		

#### 3. Other Matters for Consideration

#### Ward Members' Views

3.1. The Ward Members for Bickenhill were informed of the proposals prior to the advertising of the Notice and did not submit any objections.

#### **Democratic Services**

3.2 Democratic Services have confirmed that the notice was subject to the statutory advertisement on the dates reported and that representations were received as noted above.

#### **Risk Implications**
