Purpose of the group

- How can we make Secondary AP more cost-effective with a particular focus on 6th Day provision?
- Do secondary schools want a SISS High Needs Pathway? What does that look like?
- How much money could be devolved into secondary schools to manage their own AP? What would this look like?
- What would a lower tier model look like from Solihull Academy?
- How would any changes impact on existing Alternative Provision providers?
- How do we move from one system to another?
- What happens in other L.A's

Recommendations from the group

- 1. Continue commissioned places at S.A- explore the potential of being able to commission a place mid-year if needed. (Blackwater/Riverside model)
- 2. Offer commissioned places at Triple Crown
- 3. SEMH AP set up/offered at a current AP setting
- 4. If AP can't meet need, what/where is the next level of support on offer? Should there be a review of whether the student goes back to the home school or a new school via a managed move?
- 5. Clear KPI's for all AP's (some common/some bespoke) shared will all schools that commission places
- 6. All processes at the AP's clear (enrolment, curriculum, reporting, Q.A, etc)
- 7. Solihull Academy places more flexible, too many pathways restrict the transparently of the offer. More flexibility to potentially allow part time as well as full time places. Greater flexibility

- as year groups finish. ((year 11) Transparency around year group numbers and pathway numbers.
- 8. £608,120 currently spend on tutoring. Tutoring could be moved into schools or school hubs and the above money used to support this.
- 9. Consider the use of Blackwater, can Solihull based A.P accommodate these students? Or is sharing 'the load' a preferred option. Using Blackwater is £20.9k per pupil, £11.4k cheaper than Saturn.
- 10. A recognition from the L.A that for some students A.P is a destination (Year groups/Key Stage to be considered)
- 11. LA and AP clear roles and responsibilities

As discussed, some recommendations will:

- Save money (no.8 and 9)
- Might make money (no.1,2,3)
- Some will ensure heads have more faith in the whole system
