# DOMESTIC EXTENSIONS AND ALTERATIONS



## **Standard Charges**

The fees relate to the actual costs of providing the service and are intended to achieve full cost recovery, so that service users pay the full cost of service they receive.

The following table sets out the standard fees for domestic extensions and alterations to dwelling houses only. Alterations to domestic apartments may follow the schedule of fees in the below table, but this will be individually determined based on the complexity of the work and the height of the apartment block within which the apartment resides.

These fees are set on the basis that the design and construction of the building work does not consist/include innovative or high-risk construction techniques, is undertaken by a person or company that is competent and the duration of the work from start to finish does not exceed 12 months. If that is not the case, then supplementary charges may be made (refer to supplementary charges guidance note).

**IMPORTANT:** Please note that if a request is made to inspect work that is not ready, the work is of a poor standard or it is necessary to carry out additional visits over and above those included for within the standard charge, additional fee's will be incurred:

All proposed fees are rounded; to the nearest 50p for fees under £100 and to the nearest £1 for fees over £100

Where multiple extensions and/or multiple alterations are undertaken at the same time the Council may individually determine the fee with the agreement of the 'Principal Client/Designer/Contractor'.

If your building work requires an individual fee assessment, please email Building Control at <a href="mailto:buildingcontrol@solihull.gov.uk">buildingcontrol@solihull.gov.uk</a> with "Request for Building Regulation Fee Quote" in the title and provide a description and drawings of the proposed work. ### Reduction in standard charges

Where building work comprises or includes the erection of more than one extension to a building, the total floor areas of all such extensions may at the discretion of Solihull MBC be added together to determine the relevant fee payable, providing that the building work for all of the extensions are carried out at the same time. If the works are not carried out at the same time additional charges will be incurred:

When it is intended to carry out internal alterations, and/or structural alterations, install controlled fittings or services (excluding electrical work), ancillary to (e.g. located within or immediately adjacent to) the building of an extension/loft conversion then no charge will be made for that work, provided it is carried out at the same time. If the works are not carried out at the same time additional charges will be incurred:

#### The use of Part P registered electricians

In setting the standard charges, it is assumed that a Part P registered electrician carries out any notifiable electrical work. A Part P registered electrician is a qualified electrician who is also a member of an accreditation body (Competent Person Scheme) to certify his work. If anyone other than a Part P registered electrician undertakes the electrical work, then an additional fee is payable to the Council to cover the cost of checking the electrical installation work.

#### Other self-certification schemes (Competent Person Scheme)

There are a number of other self-certification schemes, for example Gas Safe for gas boiler installations, FENSA/CERTASS for replacement windows and doors, HETAS for solid fuel fires. #### Additional charges

An additional fee is payable where categories of building work subject to self-certification have not been carried out by a person who is a member of an accreditation body (Competent Person Scheme). This is in addition to the inspection fee, building notice fee or regularisation fee.

<sup>\*</sup> Charge includes 1 hour's structural check (NB: additional structural checking input will be charged at £50 including VAT or part thereof for any submission that goes over the allotted 1 hour).
