6 .	LA update (including Education Strategy Plan) – Bern Timings

- 6.1. Bern Timings explained that the Education Strategic Plan was currently working through political sign-off. Current MERS scheme meant that support work could not be restructured until MERS has ended. The plan will bring together around 30 projects across all education workstreams so that there is one set of reporting and monitoring. It has been formulated from the DSG Management Plan, core funding, task 7 finish groups, Jane Friswell review and Solihull Parent Carer Voice. The aim is to bring together what needs to change into one place. Some projects requiring additional resources are for 2-3 year but many projects are already underway where no further resources are needed.
- Proposing to use the £1.6m uplift and will involve schools putting forward funding too. There will be a bid process after Easter and key will be how is it going to change experiences and reduce HNB spend in the long term.
- 6.3. The Education Strategic Plan will be communicated via Headlines and in Heads' Briefings and brought to Forum.
- The Government Spring Statement did not shed any light on anything for education. We will need to be flexible so that when government give priorities we can respond.

Questions / comments

- a. Clare Thorpe asked about the Jane Friswell review as she and colleagues had given a lot of time to it but not had any feedback.
 BT replied that this was so that solutions could be given as well as the report.
- b. CT said solutions need to be co-produced and often schools have the solutions but need to be involved.
- c. BT explained the review would be shared with everyone and would come out with the Education Strategic Plan at the end of April / start of May, in advance of the next Forum papers.

Finance Working Group report (04-03-25) – Mark Firmstone

Mark Firmstone explained that the discussion at FWG echoed today's Forum meeting regarding the need for transparency and communication. FWG received Early Years and Early Years Inclusion Fund. The Early Years team have asked for inclusion funding to have an extra band (level 2.5). FWG had agreed in principle on the understanding that the financial implications were understood.

Forum agreed to recommend that the Early Years Inclusion Fund include an extra band.

- Gina Godwin said that it was not transparent how EY funding happens, the criteria were unclear and often no extra money was paid unless the setting complained.
 - Steve Fenton responded that historically no additional funding had been given for Nursery places, then with the move to NFF the Government mandated that we recognise that issue and so the Inclusion Fund was created with two bands with the idea of getting money to settings quickly as children only in Nursery for three terms. Until recently, it was only running with half a dozen plans so was not a priority. Now that has changed so the paper to FWG was an attempt to address this.
 - SF said that he would be speaking to Lisa Morris after this meeting and that she had a working group that considered SENIF.
- b. AF said it was important that this was not lost and asked where it should report into?
- c. SF suggested the usual route: working group to FWG then to Forum.

- d. Mark Pratt commented that there should be a broader view and having done a reasonable costing, that is what school then works from. That can be done using the banding and the understanding is that the cost is Section F, take £6k and then everything else is LA cost.
- e. MF said that FWG would endorse a broader review.
- f. BT commented that the lines are much more blurred and this is a key line of enquiry in the Education Strategic Plan.
- g. GG added that she has to find the skills within her staff.
- h. AF said that it was possible her school could offer support.
- i. Louise Minter added that recruitment was very difficult.
- j. Bernie Farkas commented that speech and language was almost impossible to obtain and extortionate when it was provided.
- k. SF said that we are talking about a very small percentage of children, so while they do have significant additional needs, it is very small numbers.
- MF added that it was recognised these were difficult issues but they must be worked on together to reach the solutions and he would welcome an open review.
- m. SShelton suggested that children who have an EHCP but no specialist provision place available so remain in mainstream be included as this costs a significant amount of money and schools are given no extra funding. Lots of schools are in this position and it becomes much more expensive if we don't get that part right both in terms of the cost and the effect on the child long-term.
- n. AF said that as a Chair of a special school, quite willing to offer support outside of school. Would require funding but would be possible. It comes down to education and schools not being funded appropriately full stop.
- o. KG said that we wait for Government to make an announcement. Half of councils were warning of insolvency due to SEND alone.
- p. Janice Hiorns added that there is significant pressure on staff and impact on staff wellbeing. The increasing numbers of Looked After Children is adding pressure and increasing cost too.

7b. SSSAB (13-03-25) – Louise Minter

- **7b.1.** Louise Minter explained that SSSAB met recently and had an updates from the DCS, Kara Evans, the Headteacher Coach for Early Help and Jameel Mullan, Head of EPAS. Charlotte Jones spoke about the Education Strategy Plan and some of that work will start at Partnership. Bridget and Charlotte will be attending Collaboratives.
- **7b.2.** The issue of parental complaints was raised as schools are receiving an increasing number of complaints, many of which are vexatious and nasty. Collectively we need to do something to protect headteachers and staff as the impact on class teachers is huge. It will contribute to a crisis with people no longer wanting to be teachers.
- **7b.3.** LM also discussed Admissions and Appeals costs with Jameel and Bern as schools pick up the cost of these.
- Clare Thorpe commented that Langley was not unique in being oversubscribed and appeals used to cost £250 per appeal, which has now risen to £300. ESFA give back £180 after 20 appeals but Langley have had to allocate £10k just to protect against those appeals, which takes that money away from children. She would like the LA to show some kindness as schools cannot do anything about the number of appeals. In addition to this, a permanent exclusion, which is rarely done, costs £1000, which is not even factored in. These are unseen costs and the details were sent out very late and without consultation. Headteachers sit on the panel and need to read a huge amount of paperwork, giving up a considerable amount of time. Schools are charged £185 if the parents do not turn up.
- **7b.5.** Shelton asked how the cost could be justified for lay panels that meet on Teams?
- **7b.6.** BT replied that the LA had not got a handle yet on all of the costs of traded services and he was trying to pull these together so it was clear how much extra schools are being asked to pay.

7.b.7.	SShelton added that schools do pay a service level agreement for Admissions and	
	lots of appeals come through.	
7b.8.	Lynda Mackay explained that at the SGA meeting, Clair McNeill brought Claire	
	Potts' consultation on Governors as there is a large turnover so it is important for	
	gvoernors to work together. There is a gap in governors not having full	
	understanding, particularly around the pressure on staff and heads and abuse	
	being received so this is being approached from different angles.	
7b.9.	AF said sharing of good practice and working together does happen. We have

	several new Heads of Service but there is such a wealth of knowledge and a	
	willingness to work together and for sharing good practice and skills.	
7b.10.	Mark Firmstone added that funding had been allocated for the increase in NICs	
	from April. However, this did not fully cover the cost. He provided an example of	
	the shortfall. Also, there was nothing for the increase from third party contractors,	
	whose costs will also rise to cover this.	
7b.11.	John McDermott said that across the sector, schools were receiving between 60-	
	85% of NI. The Government have only issued the details very recently and they	
	have only published the allocation, not the calculation.	
7b.12.	Councillor Burrow commented that the LA contracts out quite a lot so it is affecting	
70.12.	everywhere. It is a tax on schools.
