## **SOLIHULL METROPOLITAN BOROUGH COUNCIL**

### **The Metropolitan Borough of Solihull (Solihull Road, Catherine de Barnes Lane and Shadowbrook Lane) (Road Closures) Temporary Traffic Regulation Order 2025**

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all traffic should be restricted or prohibited to ensure that the following works can be undertaken in safety:

**Solihull Road, Catherine de Barnes** – from Eastcote Lane to Catherine-de-Barnes Lane. Alternative routes for traffic will be signed via Friday Lane, Barston Lane, Eastcote Lane. Vice versa for the opposite direction. **Access cannot be provided through the restriction for Police, Fire and Ambulance Services responding to emergencies.**

Date(s) and time(s) when restriction will apply: 22 September 2025 until 23 January 2026 (closure will be removed between 19 December 2025 and 5 January 2026).

**Catherine de Barnes Lane, Catherine de Barnes** – between Shadowbrook Lane to the northbound access road onto the new A4545 dual-carriageway (road will only be closed over the new bridge carrying Shadowbrook Lane over the A4545). Alternative routes for northbound traffic will be signed via the B4102 Hampton Lane, A41 Solihull Bypass, Yew Tree Lane, Damson Parkway, A45 Coventry Road and the new A4545 dual-carriageway. Southbound traffic will be diverted via Shadowbrook Lane and the B4102 Hampton Lane. **Access cannot be provided through the restriction for Police, Fire and Ambulance Services responding to emergencies.**

Date(s) and time(s) when restriction will apply: 22 September 2025 until 15 November 2025.

**Shadowbrook Lane, Hampton in Arden** – from junction with Catherine de Barnes Lane to Meriden Road. Width restriction on vehicles travelling on Shadowbrook Lane will be lifted to facilitate diversion. **Access will be maintained through the site for Police, Fire and Ambulance Services responding to emergencies.**

Date(s) and time(s) when restriction will apply: 22 September 2025 until 28 November 2025.

Works on behalf of: National Highways.

Reason for restriction: Bridge remedial works and associated diversion routes.

Pedestrian access to all properties within the restriction and access through the restriction will be maintained along defined routes throughout the period of closure.
