Bentley Heath Church of England Primary School is run by the Birmingham Diocesan Multi Academy Trust ('BDMAT'). The board of directors of BDMAT are the Trust's admissions body but the day-to-day administration of school admissions is delegated to our headteachers and local academy boards. The board of directors sets a standard policy for our schools to use (this policy) but the individual criteria for over subscriptions are established by the local academy board. Proposed changes to a school's over subscription criteria or amendments to this policy need approval from the BDMAT board of directors.

Our admissions process is part of the Local Authority co-ordinated scheme. Applicants must apply to their home Local Authority by the closing date.

For applicants residing in Solihull, applications are made through the Solihull Council School Admissions on-line system. This is accessed through:

The school's admission number is **30 pupils per year group**. Where the number of applications is lower than the school's admission number, all applicants will be admitted.

Oversubscription criteria

If the number of applications for a particular year group exceeds the number of places available, each application will be given a priority and places will be allocated in the following order:

Priority 1: Children looked after by a Local Authority (in accordance with section 22 of the Children Act 1989) and children who were previously looked after but ceased to be so because they were adopted or became subject to a residence order or special guardianship order. From September 2021, (conditional on the Admissions Code 2021 receiving Parliamentary approval), this includes those children who appear to the admission authority to have been in state care outside of England and ceased to be in state care as a result of being adopted.

Priority 2: Children whose exceptional social or medical circumstances can only be met by this school. Please see note 2

Priority 3: Children who normally live in the <u>catchment area</u> of the school and who would have a brother or sister on roll at the school at the time of admission (not including the nursery class)

<u>Priority 4</u>: Children who normally live in the <u>catchment area</u> of the school



<u>Priority 5</u>: Children who do not live in the <u>catchment area</u> who have a brother or sister at the school at the time of admission (not including the nursery class)

<u>Priority 6</u>: Other children, measured in a straight line from the child's home to the main pedestrian gate of the school. See note 6.

Notes:

- 1. Children with an EHC Plan that names *Bentley Heath Church of England Primary School* will be offered a place first. This may reduce the number of places available.
- 2. Applications with exceptional social or medical reasons must be supported by independent professional evidence, such as GP reports or diagnosis documents. The Cabinet Member Advisory Group for Admissions will consider applications and evidence and make recommendations to Cabinet Member, who will grant priority 2 to applications with exceptional social or medical reasons. - 3. Under priorities 3 and 5, a brother or sister must live at the same address and could be:
 - > A brother or sister sharing the same parents;
 - A half-brother or sister, where two children share one parent;
 - ➤ A stepbrother or stepsister, where two children are related by a parent's marriage or civil partnership (a formal arrangement that gives same-sex couples the same legal status as married couples)
 - > The separate children of a couple who live together; or
 - > An adopted or fostered brother or sister.
- 4. For the purposes of education law, the Department for Education considers a 'parent' to include:
 - all biological parents, whether they are married or not;
 - any person who, although not a biological parent, has parental responsibility for a child or young person - this could be an adoptive parent, a step-parent, guardian or other relative;
 - ➤ any person who, although not a biological parent and not having parental responsibility, has care of a child or young person. A person typically has care of a child or young person if they are the person with whom the child lives, either full or part time and who looks after the child, irrespective of what their biological or legal relationship is with the child.
- 5. A child's home address is the place where the child is permanently resident with his or her parent(s). When a child lives between two addresses, the address used for offering a school place will be where the child lives for most of the school week (Monday to Friday).



If care is split equally, the parents can choose which address will be used. [In the event of a dispute between parents who each have parental responsibility, the matter may ultimately need to be resolved by the courts.]

- 6. If offering places within any one of the criteria would cause the school's admission number to be exceeded, then children living nearest will be offered first. Distances are calculated by the Local Authority in a straight line from the child's normal home address to the main pedestrian gate of the school using the Local Land and Property Gazetteer (LLPG). This is the only measure used and distances provided by other websites, such as Google Maps, will not be considered. If two or more applicants share the same distance to a school and only one place is available, the applicant to whom the place will be offered will be determined by the Local Authority by random selection (unless this involves multiple births, in which case, all the siblings will be admitted).
- 7. **Late applications -** Applications received after the Local Authority's designated closing date for receipt of applications will be deemed to have been made late and will be considered after applications with the same priority that were received on time.
- 8. **Waiting lists** are held in strict order of priority, according to the oversubscription criteria and managed by Solihull Council. Parents must email the council every half term to keep their child's name on the list. As each child is added to the waiting list, lists are ranked again in priority order.
- 9. Applications made outside the normal admissions round (for in-year admissions) should be made directly to the Local Authority through their systems. Details can be found at https://www.solihull.gov.uk/Resident/Schools-learning/schooladmissions/Schooladmissions If there is a vacancy in the relevant year group a place will be offered. If the year group is full the application will be given a priority and put on the waiting list.
- 10. **Appeals**: Parents who wish to appeal against a decision to refuse their child a place in the school may apply to the Local Authority for a hearing. Appeals will be heard by an independent Panel.
- 11. **Fair Access Protocol:** The Local Academy Board recognises its duty to participate in the Local Authority Fair Access Protocol.
- 12. Admission of children below compulsory school age and deferred entry:
 - 12.1 A child is entitled to a full-time place at school in the September following their fourth birthday. The child's parents can defer the date their child is admitted to the school until later in the school year, but not beyond the point at which they reach compulsory school age and not beyond the beginning of the final term of the school year for which application was made.



- 12.2 Where parents wish, children may attend part-time until later in the school year but not beyond the point at which they reach compulsory school age.
- 12.3 Compulsory school age is the prescribed day on or following the child's fifth birthday. The prescribed days are **31 December**, **31 March and 31 August**, e.g.: A child born between 01 September and 31 December must be in compulsory education by 31st December. A child born between 01 January and 31 March must be in compulsory education by 31 March. A child born between 01 April and 31 August must be in compulsory education by the beginning of the final term of the school year (unless the provisions relating to summer-born children below are applied).

13. Admission of children outside their normal age group

- 13.1 Parents may seek a place for a child outside of their normal age group in special circumstances, for instance if the child is gifted and talented or has experienced problems such as ill health. Such applications should be made in writing to the Chair of the Local Academy Board of the school, via the school office, setting out the reasons for the request. A decision will be made on the basis of the circumstances of each case and in the best interests of the child concerned.
- 13.2 <u>Summer-born Children</u> (those born between 01 April and 31 August)
- 13.2.1 Parents of a summer born child may choose not to send their child to school until the September following the child's fifth birthday, when they will apply for the child to enter Year 1. There is no guarantee that a place will be available at the school at this stage, as the year group may well already be full.
- 13.2.2 Parents of a summer born child may, at the same time as making an application to the Local Authority for a Reception place in the child's normal age group, make a request to the school's Local Academy Board that the child may **reapply** the following year to be admitted to the Reception class in the September following the child's 5th birthday instead. The request should be made in writing to the Chair of the Local Academy Board of the school, via the school office, setting out the reasons for the request and the request. The Local Academy Board will make its decision on the basis of the individual circumstances of each case and in the best interests of the child concerned and will set out clearly the reasons for the decision.

If the Local Academy Board <u>agrees</u> to the parent's request, the existing application for the Reception place may be withdrawn and the parent must then make a **new** application for a place in Reception as part of the main admissions round the following year which will be considered against the normal oversubscription criteria, (and there is no guarantee of a place being offered at this school at that stage).



If the Local Academy Board does <u>not agree</u> to the parent's request, the parent must decide whether to accept any offer of a place for Reception for the normal age group, or to refuse it and make an in-year application for admission to Year 1 for the September following the child's fifth birthday (when, again, there is no guarantee of a place being available at this school).

- 13.3 A decision made by one admission authority in respect of admission of a child out of their normal age group is not binding on any other admission authority. Therefore, a child educated out of their normal age group at this school may not be accepted out of their normal age group when moving to a different school or from primary to secondary school.
- 13.4 Parents' statutory right of appeal against a decision to refuse admission does not apply if the child is offered a place at the school but it is not in the parent's preferred age group.
